Greg Kossover, Chair

Gregory H. Kossover has served as Executive Vice President of Equity Bank since October 2013, as Chief Financial Officer from 2013 to 2020 and COO beginning in July of 2020. Kossover has served as a member of the board of directors since December 2011. Prior to joining the company, Kossover was President of Physicians Development Group, a builder and manager of senior living facilities in the Wichita area. He was Chief Executive Officer of Value Place, LLC, one of the largest economy extended-stay lodging franchises in the United States. Kossover previously served as Treasurer of Western Financial Corporation, a publicly held thrift holding company. Kossover graduated from Emporia State University with a Bachelor of Science degree in Accounting and has successfully completed the Uniform Certified Public Accountants exam.

Cynthia Lane

Dr. Cynthia Lane has more than 36 years of professional experience in the field of education. Dr. Lane is currently the CEO of Evolve Education Leadership, LLC, and serves on both the Governor's Council of Education and the Advantage Kansas Coordinating Council. Dr. Lane was the superintendent of Kansas City, Kansas Public Schools from 2010 to 2018, and received her Ed.D. from the University of Kansas along with her M.S. and B.S. Ed. from Pittsburg State University. Dr. Lane was appointed to the Kansas Board of Regents in June 2021.

Blake Flanders

Blake Flanders serves as President and CEO for the Kansas Board of Regents. The Kansas Board of Regents is the governing board of the state's six universities and the statewide coordinating board for the state's 32 public higher education institutions (seven public universities, nineteen community colleges, and six technical colleges). In addition, the Board administers the state's student financial aid, adult education, GED, and career and technical education programs. The Board also authorizes private proprietary schools and out-of-state institutions to operate in Kansas.

Prior to serving as President and CEO, Blake served as the Vice President for Workforce Development for the Board of Regents and as the liaison between the Board and the Kansas Department of Commerce. Blake is a graduate of Colby Community College and Kansas State University where he earned a Bachelor of Science in Animal Science, Master of Science in Animal Science, and Doctorate of Philosophy in Curriculum and Instruction. Before joining the Board office, he served as Vice President of Instructional

Services at Manhattan Area Technical College, and as a member of the faculty at Butler Community College. Blake and his wife, Risa, have three children and reside in Topeka.

Joan Brewer

Dr. Joan Brewer currently serves as the Dean of The Teachers College at Emporia State University. Prior to becoming Dean, Brewer held the role of Associate Dean, leading the University through a successful Council for the Accreditation of Educator Preparation (CAEP) accreditation. As a result of this accreditation work, ESU was recognized as an inaugural recipient of the Frank Murray Leadership Recognition for Continuous Improvement, an award recognizing those institutions that receive no areas for improvement or stipulations. Brewer is a full professor in Health, Physical Education, and Recreation and has served as a department chairperson. An ESU alum (BSE '91; MS '94), Brewer has been a faculty member at ESU for 20 years. She has numerous publications and presentations, including a multi-sport curriculum used by the USA Triathlon Association. Brewer has received the American Association of Health, Physical Education, Recreation and Dance (AAHPERD) Mabel Lee Award, the Central District AAHPERD Honor Award, an ESU Teachers College Outstanding Recent Graduate recognition, and the Ervay Family Award for Applied Scholarship. Brewer is a Kansas licensed teacher in mathematics, physical education, and computer studies. She is also a Certified Exercise Physiologist through the American College of Sports Medicine.

Brenda Koerner

Dr. Brenda Koerner is the President of the Faculty at ESU. Prior to her election to Faculty Senate leadership, she served as the chair of the Academic Affairs committee for two years, and has been a member of Faculty Senate since 2016. She is also an associate professor in the Department of Biological Sciences at ESU, teaching courses in ecology, botany, and biology education. Her current areas of research are management of invasive plant species, fire ecology, and plant-microbe interactions. She has been a member of the faculty at ESU since 2005.

Greg Larson

Greg Larson is the Budget/Project Coordinator for Information Technology at Emporia State University. He has worked in several positions during his 30-year career at ESU, including MU Bookstore manager, MU Assistant Director for Business Operations, and ESU Ticket Manager. He serves as president of the Staff Senate and led the combining of Unclassified Professional Senate and University Support Staff Senate into one group. He has served on the Memorial Union Board of Directors, the Parking Committee, Faculty Senate (2 terms), the Technology Committee, Emporia Friends of the Library Board, and Messiah Lutheran Church Board of Elders. He has three children and a niece who have attended ESU and have earned six degrees. He also is a member of the Kellogg Society, whose members commit legacy estate gifts to the University.

Erin Mykleby

Erin Mykleby graduated from Luther College in 2012 with a Bachelor's Degree in Physical Education, while also receiving her Master's Degree from the University of Iowa in Sports Management in 2014. He served as Department Chair, Associate Dean, Interim Dean, and Acting Assistant Vice-President. As a faculty athletics representative, Rich was elected President of the MIAA and chaired the NCAA Division II Academics Requitement Committee. At ESU, Spotswood has led accelerated online program (AOP) efforts within the Graduate School and open educational resource (OER) efforts across campus.

Brent Thomas is the Dean of the College of Liberal Arts & Sciences and a professor in the Department of Biological Sciences. He joined the Hornet Nation in 1999 as a member of the biology faculty, and later served as the Department Chair for about six years prior to being named as the dean of the college in 2014. An opportunity to participate in an undergraduate research project outside of the traditional classroom setting had an enormous impact on his career and life. Dr. Thomas believes that high impact learning experiences such as these serve as effective mechanisms to change lives for the common good, and he values ESU's long tradition of providing students with such opportunities. In all his roles at ESU, he has served as a passionate spokesman and effective advocate of building upon this tradition by expanding opportunities for high-impact learning within the Hornet Nation. Dr. Thomas received his bachelor's degree in biology from the University of the Ozarks (Clarksville, Arkansas), a master's degree in biology from Southwest Missouri State University (Springfield, Missouri), and a doctorate from Mississippi State University (Starkville, Mississippi). Prior to joining the Hornet Nation, he served as a member of the biology faculty for seven years in the Department of Natural Sciences & Engineering at the University of South Carolina Upstate (Spartanburg, South Carolina). He and his wife, Stephanie, live in Emporia and are the proud parents of two current students at Emporia State University.

Xavier Cason is a senior at Emporia State University who is majoring in elementary education.
